





REPORT ON ACTIVITIES FOR PERIOD COMMENCING 22ND MAY 1990 AND ENDING 21ST MAY 1991 ON EXPLORATION LICENCE 6763.

Regretably, with the unexpected cancellation of Exploration Licences 6133 through 6136 on the 16th May 1990, our orderly programme for 1990 was immediately thrown into disarray as we scrambled to salvage some of the sites we had identified on these areas.

Later in 1990 and during the first quarter of 1991 we have, under extreme difficulty, managed to spend some time on Exploration Licence 6763. We have located traces of Aquamarine and Garnet and have identified some areas that applications will be lodged for Mineral Claims later this year.

REPORT OF PROPOSED ACTIVITIES ON EXPLORATION LICENCE 6763 FOR THE ENSUING TWELVE MONTHS.

Our Field Operations Manager Mr. Ben Pope and his son Mr. Samuel Pope will be conducting further examinations of Exploration Licence 6763 before commencing the necessary ground work in preparation of our Mineral Claim applications. Because of commitments to other Exploration Licences and Mineral Claims, we have not been able to complete this work before the anniversary of this licence.
