SUMMARY OF ACTIVITIES

EL 9840 Foelsche River is located 105 km south of Borroloola and 32 km south east of the Merlin Diamond Mine, Northern Territory, Australia.

RTE reviewed the historical exploration for EL 9840 during the period. The review failed to identify any kimberlitic targets of immediate interest to RTE.

The area covered by EL 9840 has been previously sampled by Ashton Mining. Several of Ashton's samples contained diamonds and other indicator minerals.

EL 9840 is located over the Neoproterozoic Georgina Basin in the northeast and an uplifted horst block of Tawallah Group and Roper Group belonging to the Mesoproterozoic McArthur Basin in the southwest. NW-SE trending structural lineaments traversing the Merlin kimberlite field can be interpreted to traverse EL 9840. Regional airborne magnetic and gravity data interpretation highlighted major lineaments and geological domain contacts in the region spatially associated with kimberlitic intrusions. The interpretation indicated that EL 9840 is prospective for kimberlite intrusions.

RTE did not carry out any field-based exploration within EL 9840 during the current reporting period. The EL is currently being divested along with neighbouring EL's belonging to the Merlin Orbit Diamonds Project.
