The abovementioned exploration licences have been granted Combined Reporting status with an annual submission date of 5 March.

Although included in a recent prospectivity review, activity was confined to office studies. A review of Exploration Licence 10050 was undertaken with respect to the mineralisation at the Wapiti prospect on adjacent tenement EL 23122; and this review also resulted in the surrender of Exploration Licence 10051 on 5 January 2006 (final report to follow). Discussions with the Central Land Council about access and work area clearances in the area have progressed positively.

As no field work has been conducted for either tenement in the combined reporting period, we ask that this letter be accepted in lieu of the combined annual report.

Summary of Activities - Year Three

In the third year of tenure, no fieldwork was undertaken on EL 23122 due to minor problems obtaining access for drilling. Ongoing discussions with the Central Land Council have been positive, and further meetings with traditional owners are planned for the immediate future. It is expected that access will be permitted in the first half of 2006. The rediscovery of the Wapiti prospect on EL 23122 in 2004 has provided great encouragement to discover a new gold district.
