2005 WORK PROGRAM FOR EXPLORATION LICENCE 23391

Introduction

Exploration Licence 23391 is a part of Discovery Nickel Limited's (DNL) Arunta Project which comprises exploration tenements 23391, 23392, 23393, 23395, 23629, 23271 and tenement applications 23394, 23396, 23397, 23398 and 23399. Discovery Nickel is exploring the Palaeoproterozoic rocks of the Arunta Province for Voisey's Bay style nickel-copper deposits. Discovery Nickel acquired the Arunta Project from Falconbridge (Aust.) Pty Ltd following the successful listing of Discovery Nickel on the Australian Stock Exchange on 17th December 2003.

Most significant nickel-copper massive sulphide deposits are extremely good conductors. Discovery Nickel's exploration approach relies heavily on airborne electromagnetic (EM) surveying, followed by ground EM to define targets. Drilling on our Arunta tenements to date includes two diamond holes on adjacent tenement 23392 and 23074. Drilling at J1 on 23074 failed to intersect anything significant however drilling at prospect B1 on EL 23392 south east of EL 23391 intersected a significant new sulphide system. New Airborne EM (GEOTEM) was collected during October 04 over EL 23391 and part of EL 23395. Interpretation of the data over EL 23391 shows there are anomalies in the GEOTEM data that require further investigation.

Work Program

DNL plans to cover new bedrock conductors with ground EM. If ground EM confirms the conductive features as bedrock conductors then RC or diamond drill testing of these new targets will be undertaken.

The allocated budget for further work on EL 23274 including funds for ground EM follow up of airborne EM targets, followed by RC drilling is \$27083. Included in this budget are the following items:

- Additional interpretation of airborne GEOTEM data
- 2 days of ground EM surveying
- Interpretation and processing of the ground EM data
- Clearance of the proposed drill sites by the Traditional Owners
- 120m of RC drilling
- Contract geologist/geophysicist
- Field Support (vehicle hire, field technician, travel)
- Rehabilitation
- Tenement Fees

Introduction

Exploration Licence 23391 is a part of PROTO Resource and Investment Limited's (PROTO) Arunta Project which comprises exploration tenements 23391, 23392, 23393, 23395, 23629, 23271 and tenement applications 23394, 23396, 23397, 23398 and 23399. PROTO is exploring the Palaeoproterozoic rocks of the Arunta Province for Voisey's Bay style nickel-copper deposits. PROTO acquired the Arunta Project from Discovery Nickel Limited (DNL) in 30 June 2006.

Most significant nickel-copper massive sulphide deposits are extremely good conductors. Discovery Nickel's exploration approach relies heavily on airborne electromagnetic (EM) surveying, followed by ground EM to define targets. DNL Drilling on our Arunta tenements to date includes two diamond holes on adjacent tenement 23392 and 23074. At B1 on EL 23392 south east of EL 23391 drilling intersected a significant new sulphide system. New Airborne EM (GEOTEM) was collected by DNL during October 04 over EL 23391 and part of EL 23395. Interpretation of the data over EL 23391 shows there are anomalies in the GEOTEM data that require further investigation.

Work Program

PROTO plans to cover new bedrock conductors with ground EM. If ground EM confirms the conductive features as bedrock conductors then RC or diamond drill testing of these new targets will be undertaken.

The allocated budget for further work on EL 23274 including funds for ground EM follow up of airborne EM targets, followed by RC drilling is \$46083. Included in this budget are the following items:

- Additional interpretation of airborne GEOTEM data
- 4 days of ground EM surveying
- Interpretation and processing of the ground EM data
- Clearance of the proposed drill sites by the Traditional Owners
- 240m of RC drilling
- Contract geologist/geophysicist
- Field Support (vehicle hire, field technician, travel)
- Rehabilitation
- Tenement Fees
