1. <u>SUMMARY OF ACTIVITIES</u>

The Jandapa Hill Project consists of two granted Exploration Licences, EL 25395 and EL 27591, granted on 01/12/2009 under the name Territory Uranium Company Ltd. Rio Tinto Exploration has an option agreement with Territory Uranium to conduct exploration on the project for bauxite. This report covers activities on the tenement EL 27591, Jandapa 2 and does not include activities on EL 25395, Jandapa 1.

EL27591 was split out of the original application area of EL25395 upon grant. This tenement covers 5km² which is approximately 1% of the original area. The area has bauxite potential however the work programmes are contingent on the completion of work and positive indications of bauxite within the granted area of EL25395.

To date, due to unforeseen access issues to the priority target area, the work has not been able to be completed.

No ground work was completed on EL27591.
