REGIONAL

Rock Chip Geochemistry

In the course of reconnaissance work in a number of areas prior to detailed grids being established a total of 65 rock chip samples were collected. The location results and lithologies are shown on 1:100,000 enclosures 4-8, 3498 and complete geochemical data contained in appendix 1.

Some of the areas sampled - e.g. High Chinese - were subsequently explored in more detail on a grid system. Others - e.g. the south end of Bonnie Line - where there are a number of zones of gold-arsenic rock chip anomalies as well as aeromagnetic anomalies - should be explored in more detail in due course.

Topographic Mapping

Additional topographic mapping (based on 1987 1:10,000 scale photography) was planned but not completed during the year. Several survey central points were picked up and triangulation completed. Before any detailed work is carried out on the Eureka or High Chinese prospects it would probably be worthwhile acquiring the topographic mapping for sheets 43-45 and 51-53 (shown on figure 4.) and additional sheets to the south along strike.

Geological Mapping

A programme of 1:5,000 scale geological mapping by H. Davies of Remote Sensing and Geological Services (who carried out 1:10,000 scale mapping in 1987) was initiated during the year. Starting in the area of the open pits.


The mapping - using 1:5,000 air photos and enlargements of 1:10,000 photos was designed to eventually extend to the Dingo - Waterhole area to the west, Mango to the north. High Chinese to the south and El Dollarado to the east. Because of logistical problems associated with the airline dispute the mapping was not completed, however, data collected are shown on enclosure 184.

EXPENDITURE

Expenditure statements for EL's 4492, 4508, 4894 and 5674, MLN's 1059, ERL's 75 and 76 and MCN's 1908-1913, 1925-1930, 2944-2957, 3042-3081, 3088-3098 and 3181-3187 are attached.

As January 15th has been previously chosen as a reporting date for the whole project area and December 31st is the closest Cyprus accounting date, the expenditure statements are for the period 1st March 1989 - 31st December 1989.

Exploration expenditure for the year totals \$1,278,382.23 subdivided on a tenement basis as follows:



EL 4492

The \$25,099.43 expenditure can be considered to apply to Year 6 of the Licence (ending 15th March, 1990). The total for this Licence is now \$118,016.25.

EL 4508

The 1989 expenditure of \$3262.12 can be considered to apply to Year 6 of the Licence (ending 24th May, 1990). The total for this Licence is now \$56,019.25.

EL 4894

The listed expenditure of \$37,668.88 can be considered to apply to Year 4 of the Licence (ending 27th May, 1990). Total expenditure is now 91,522.38.

EL 5674

The listed expenditure of \$11,206.36 can be considered to apply to Year 2 of the Licence, (ending 12th April 1990). Total expenditure is now \$21,772.93.

MLN 1059, ERL 75, ERL 76

Expenditure on these tenements for the 10 months to 31st December, 1989 was \$1,138,396.91 of which 97.5% (\$1,109,936.99) can be attributed to MLN 1059/ERL 76 (same area).

Total exploration expenditure for MLN 1059/ERL 75 is now \$1,938,914.43 and for ERL 76 is \$120,568.53.

Expenditure for the year for this MCN ground was \$62,748.52. There was no previous expenditure on this ground.
