EL 26978 is located some 600km to the south of Darwin in the Northern Territory.

The licence has a regular shape having a north-south length of 20km with an maximum eastwest width of 30km and lies between 17° 57′S to 18° 8′S and 130° 53′E to 131° 10′E.

The licence is located upon pastoral land "Wave Hill Station" which is owned by Gambamora Industries Pty Ltd (PO Box 104 Coolangatta QLD 4425).




Figure 1 Location Map

## 2. TITLE HISTORY

## Mineral Tenure

EL 26978 was granted to FSL World Holdings Pty Ltd in accordance with the *Mining Act* on 23/07/2009.

The licence was purchased by Fertoz Ltd in late October 2010 who held the title for 3 years.

The licence was then purchased by FSL Corporation Pty Ltd in October 2013.

This is the Partial relinquishment Report which covers activities in the period 23/07/2009 to 28/11/2014. Before partial relinquishment the licence had an area of 184 graticular blocks (600.9 km²), through the process of relinquishment the licence has had 90 graticular blocks of the area dropped and subsequently now has an area of 94 graticular blocks (300 km²).




Figure 2 EL 26978 before relinquishment




Figure 3 EL 26978 after relinquishment
