### **Annual Reports for 'Nil Activity' for MLN276 (Mary River)**

Please be advised that Boral Resources (QLD) PTY Limited, the Holder of Mineral lease 'MLN276' located off the Arnhem Highway, South of the Mary River Bridge. The title was originally granted on the 17/10/1975 was due to expire on 31<sup>st</sup> December 2016. A renewal application for the title was lodged with the department of Primary Industry and Resources on 28<sup>th</sup> December 2016 and remains under review at the date of this report.

During the previous term and to date Boral have not extracted any sand from this location due to the lack of any operational requirement for Granite Sand and difficulties in the extraction process of sand in the bed of the Mary River. In addition, Boral was made aware that the title falls within an area that may be the potential site of a crocodile hatching area.

For the reporting Period 1<sup>st</sup> January 2017 – 31<sup>st</sup> December 2017 Boral resources (QLD) Pty Limited did not undertake any extraction of sand from the site as it is not subject to a *Mining Management Act* Authorisation. In addition, extraction of sand from this site depends upon the grant of an Authorisation to undertake Activity.
