Lease 913. The claims cover an area of some 228 hectares. The station homestead is situated approximately 8 kilometres east north-east of the mineral claims.




Figure 1: Location Map




Figure 3: Tenement Map MCN205, 206, 207, 208, 983, 984, 985, 986, 987, 988, 989 & 990
