The licence is located upon pastoral land, "Alroy Station" which is owned by the Stanbroke Pastoral Company Pty Ltd.




Figure 1 Location Map

This is the Second Annual Technical Report which covers activities in the period 30/07/2013 to 29/07/2014.




Figure 2 ELs 29193, 29194, 29195 and 29196
