1. LOCATION

EL 30008 is located some 250km to the east of Tennant Creek in the Northern Territory. The licence has a regular shape having a north-south length of 24km with an maximum east-west width of 21km and lies between 19° 35'S to 19° 48'S and 136° 36'E to 136° 48'E. The licence is located upon pastoral land "Alroy Station" which is owned by the Stanbroke Pastoral Company Pty Ltd.

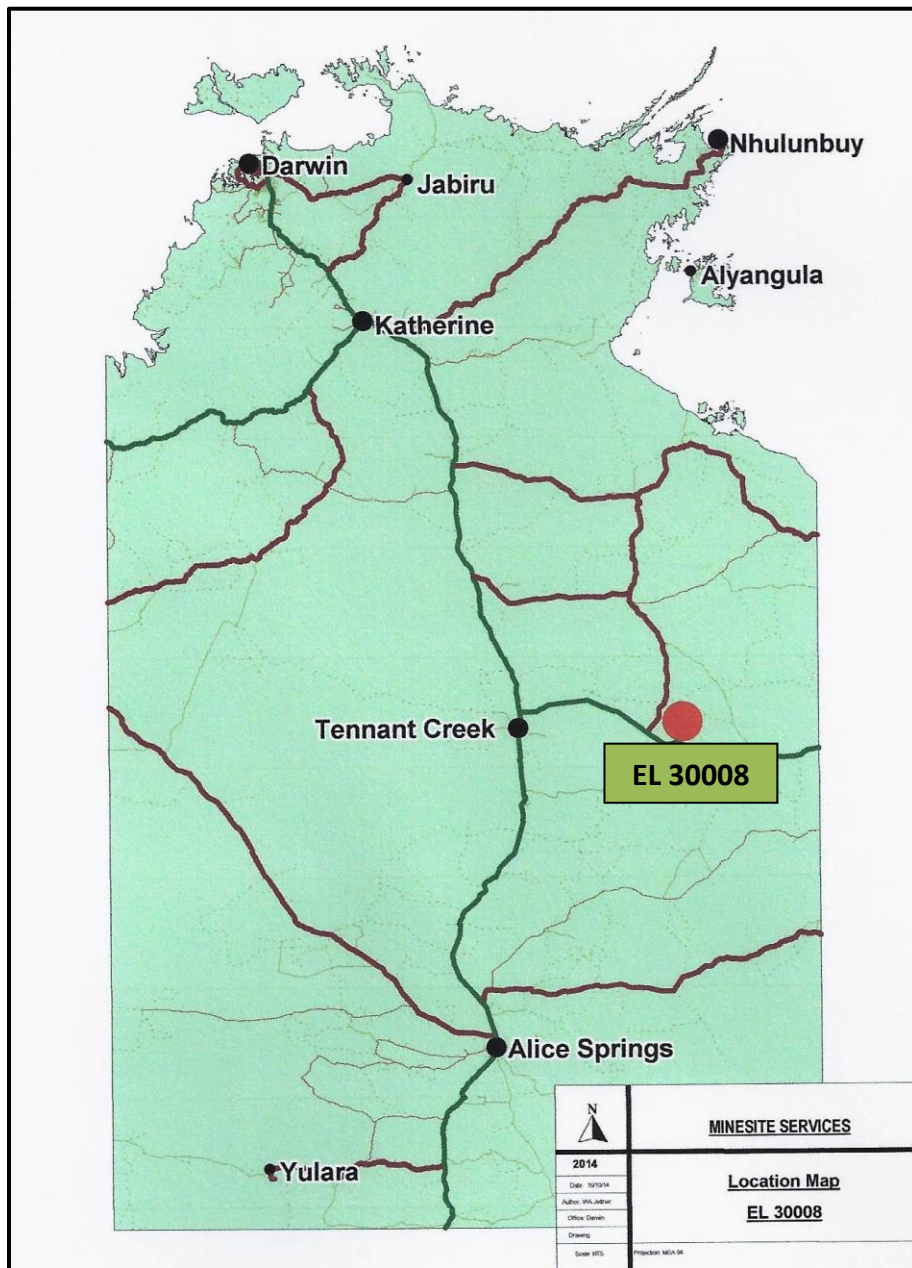


Figure 1 EL 30008 Location Map

2. TITLE HISTORY

Mineral Tenure:

EL 30008 was originally part of EL26055 and was split off to form EL 30008 in accordance with the *Mining Act* on 23/07/2013. It consequently has the same age and anniversary dates as its parent licence.

The licence was purchased by FSL Corporation Pty Ltd in October 2013.

This is the Sixth Annual Technical Report which covers activities in the period 5/09/2013 to 4/09/2014. During this period the licence had an area of 15 graticular blocks (48.7 km²).

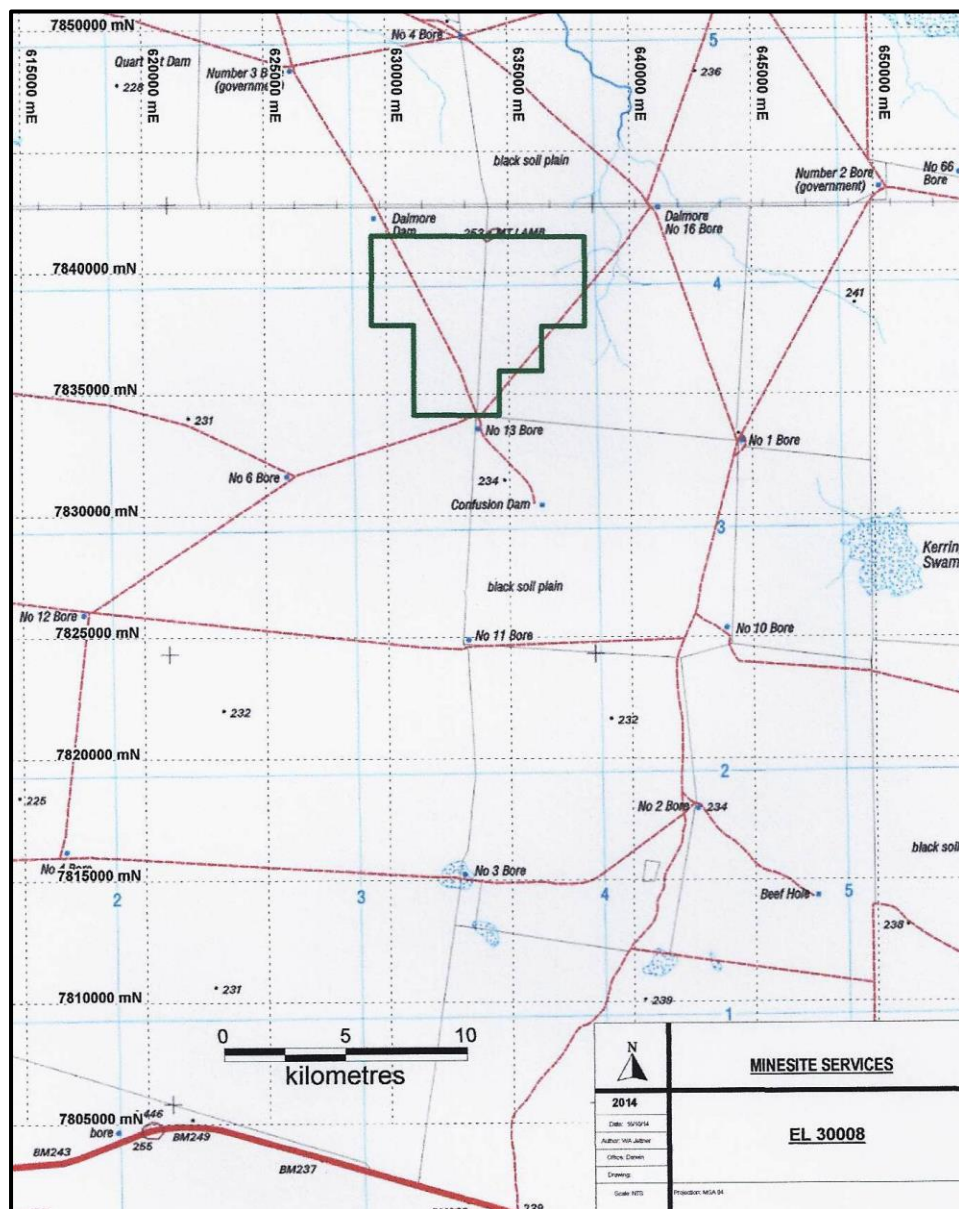


Figure 2 EL 30008
